Progress On Charge:

SLC is investigating the use of the ETS Proficiency Profile, which is a general education outcomes assessment. A pilot of the ETS Proficiency Profile was done during the Spring 2012 semester. The results were reviewed by GERT and recommended that BHC continue the use of the ETS Proficiency Profile during the Spring 2013 semester.

In addition, SLC recommends suspending the use of the General Education/Core Curriculum Grid, (See Attached), and replacing it. The current thoughts for replacement are using the following three items assessed across the curriculum: (1) Students can think critically, (2) Students can solve problems; (3) Students can communicate effectively.

Recommendation to Senates:

- 1. Recommendation is to suspend the use of the General Education/Core Curriculum Grid effective January 1, 2013 and to charge the Student Learning Committee to acquire feedback from Academic Departments and propose a new system for assessing General Education outcomes at BHC.
- 2. The senates should approve the use of the ETS results for reporting.
- 3. Recommendation is for the Senates to discuss the development of a process for assessment of student learning for programs such as Mathematics, English, History etc. This 3rd recommendation is beyond the scope of the SLC.
