Here are the questions received, in order, by the deadline of 5:00 pm September 13, 2019, and their answers:

Q: Proposal Requirements (Page 4) – Several of these Requirements ask for Descriptions; however, Proposal Preparation and Submittal (Page 7), does not include a section to address them (with the exception of No. I, vendor information. Please clarify.

A: Proposal Requirements A., B., C., E., F., G., & H., (Pages 4 & 5) would fall under Proposal Preparation and Submittal 4) Cost Proposal (Page 7).

Proposal Requirements D., I., J., K., L., & M. (Pages 4 and 5) would fall under Proposal Preparation and Submittal 2) Vendor Information (Page 7).

If your proposal is done in this fashion, then we will have all of the descriptions and information we need.

Q: Proposal Preparation and Submittal (Page 7) – This section requires three (3) hard copies, each in its own binder, plus one (1) electronic copy of each proposal, and delineates the four sections to be included. The Instructions to Vendors (Page 13); however, requires three (3) hard copies and one (1) electronic copy of the Pricing Proposal. Please clarify.

A: Please provide your proposal as instructed on Page 7.

Q: Instructions to Vendors (Page 13) – This section also requires two (2) copies of Attachment C, one (1) copy of Attachment D, and one (1) copy of Attachment E. How are these copies of the various Attachments required to be included in the package? Loose sheets? Additional Binder? In an envelope?

A: Providing two (2) copies of Attachment C, one (1) copy of Attachment D, and one (1) copy of Attachment E in a separate envelope would be fine.

Q: Do you allow Electronic Signatures on the RFP response?

A: No, please provide original, wet ink signatures on all documents requiring signatures.

Q: Is BHC looking for the cost of a VxRail Node or only the labor to install a VxRail Node?

A: Please provide pricing for both the Node and the Labor to install.

- Q: What QTY of Cisco part numbers do you want quoted? QTY's are not listed in the bid specs.
- A: Please propose pricing based on quantity of one (1) each.
- Q: Concerning the below, do they have a specific requirement for cable manufacturer, color, rating, etc?
