**Note**: Alphabetize and double-space the entire reference list. All lines after the first line of each entry in your reference list should be indented one-half inch from the left margin, this is a hanging indentation.

# Examples of APA Style – 7<sup>th</sup> Edition – **Online**

## Listed below are some of the revisions to APA documentation style for online sources.

- Digital object identifiers (DOIs) or URLs are now both presented as hyperlinks for electronic sources. (A DOI is a unique and persistent identification number assigned to a digital object).
- Academic database information and URLs are not usually included in citation entries, include when citing sources that are only available within a certain database. Always include DOIs.
- Use "Retrieved from" (preceding the URL or DOI) only when a retrieval date is also provided in the citation. Include retrieval dates if the source material may change over time.
- Provide surnames and initials for up to and including 20 authors. When there are two to 20 authors, use an ampersand before the final author's name. **This is also true for print sources.**
- When there are 21 or more authors, include the first 19 authors' names, insert an ellipsis (but no ampersand), and then add the final author's name. **This is also true for print sources.**
