



Completing the FAFSA

- Complete your FAFSA as soon as possible after Oct. 1 each
- Submit your FAFSA online at www.fafsa.gov. It's FREE!
- Students under the age of 24 will be required to provide p information unless they are:
 - Married
 - Veteran/active duty
 - Orphan/ward/ emancipated minor • Graduate student
- Court-ordered legal guardian
- Supporting child(ren)/dependent
- Homeless



Tips for Success

- New users (both students and parents) should create an FSA ID at www.fsaid.ed.gov at least 2-3 days before completing the FAFSA. This is the electronic signature required for students and preferred for parents.
- /isit www.bhc.edu/FAforms for instructions on:
 - Creating an FSA ID.
 - Linking your BHC email to a personal email account.
 - Reviewing your financial aid information on myBlackHawk.
 - Using the IRS Data Retrieval Tool.
 - And other useful information!
- Regularly check your myBlackHawk and BHC email accounts Communication with students is electronic and only available through these school accounts.
- Keep an eye out Financial aid notifications will be emailed in March-April 2019.





DID YOU KNOW? To continue receiving financial aid, students must make "satisfactory academic progress" toward earning their degree. Students must: 1) maintain a 2.0 cumulative GPA, 2) earn 67% of total credit hours attempted, and 3) attempt no more than 96 credit hours for an associates degree or 48 credit hours for a certificate. What documentation do we need?

To submit a FAFSA, both student and parent will need:

- FSA ID
- Social Security Number (citizens)
- Permanent Resident document (non-citizens)
- Current banking statements
- 2017 federal income taxes
- 2017 W2/1099 forms
- Records of untaxed 2017 income
- Records of assets and investments
- do not include retirement

My FAFSA's done – Now what?

Congratulations! You've submitted your application and have completed the first step in applying for financial aid. But now what?

- Understand your anticipated costs so you can budget your financial aid (www.bhc.edu/tuition).
- Additional information may be needed, so watch for financial aid requirements. Notifications will be sent to BHC emails beginning March-April 2019.
- BHC scholarships require a separate application, which is available March 1 and due May 1 (www.bhc.edu/scholarships).
- Know that Finish Financial Aid Day is July 1, 2019 Students should submit all financial aid requirements by this date in order to have funds in place by the fall payment deadline of July 24, 2019.
- Students who do not complete requirements by July 1 should prepare to make deferred payment arrangements to hold their fall classes (www.bhc.edu/payments).
- To be considered for federal student loans, complete the BHC Loan Application and requirements at www.bhc.edu/loans.
- Be aware that enrollment and financial aid are finalized on the 10th day of the semester. Courses added after the 10th day will not be eligible for financial aid.
- Consult with the Financial Aid Office before dropping any classes as your eligibility may be affected.
- To continue receiving financial aid each semester, students must meet Satisfactory Academic Progress requirements (www.bhc.edu/financial-aid-policies).
