

**Updated information for students planning to transfer to  
St. Ambrose University.**

**Incorporate these changes while using the transfer guide that follows.**

Students transferring in fall 2026 or later will no longer need to meet St. Ambrose graduation requirements for a second language, and in health and fitness. SAU is ending these two requirements effective fall 2026.

Black Hawk courses affected may include HEAL 102, HEAL 200, PE 125, SPAN 101, and SPAN 102. While these courses are still transferrable to SAU, and may be needed for certain majors, they are not needed to meet general education requirements starting fall 2026.

# Articulation Agreement

## AAS Cybersecurity

### transfer to bachelor's degree



This Agreement is made between Black Hawk College (BHC) and St. Ambrose University (SAU), collectively the Parties, to set forth the terms and conditions of engaging in an educational program and to facilitate the transfer of students who earn, or enroll in courses leading to, an **Associate of Applied Science in Cybersecurity (AAS-Cyber) degree**. BHC and SAU jointly support the goal of students attaining an AAS-Cyber degree and a bachelor's degree through this Agreement. This Agreement does not prevent students from participating in additional programs established between the Parties to the extent the programs are applicable to Applied Science degrees such as dual admission, dual enrollment, guaranteed admission and reverse transfer programs. BHC and SAU will maintain the integrity of their separate admission and academic programs and enter into this Agreement as equal and cooperating partner institutions.

#### Purpose

This Agreement between BHC and SAU is intended to increase academic opportunity, minimize duplication of instruction and enhance career pathways by providing a seamless curriculum transition for BHC AAS students who transfer to SAU to earn a bachelor's degree.

This Agreement is designed for students who follow a prescribed plan of study leading to an Associate of Applied Science degree. As outlined in the Appendix to this Agreement, up to 64 BHC credits will be applied to the total credit hours required for the bachelor's degree. All other standard admission, curriculum and graduation requirements of the Parties must also be met.

#### Program Articulation

The Parties agree that any student who has earned the **AAS-Cyber** degree may transfer the credits from their program, as outlined in the attached Appendix, to SAU toward the

- **Bachelor of Arts in Cybersecurity**

This Agreement specifically allows the transfer of up to sixty-four (64) total credits including twenty-four (24) technical/vocational credits.—A grade of "C" or better is required to award transfer credit. A minimum of 56 credits will be taken at SAU. Additional courses taken at BHC that fulfill SAU major and general education requirements do not need to be repeated at SAU.

#### SAU Admission and Graduation Requirements

For admission, students must submit all prior high school and college or university transcripts. Students must maintain a cumulative GPA, including prior college or university credits, of 2.0 or higher.

For graduation,

- All students must complete 6 additional semester hours of Philosophy and Theology at St. Ambrose, with at least one course in each area, one of which must be at the 300/400 level.
- All students must satisfy all non-distributional requirements after transfer, including: 30 hours of 300 level or above courses, GPA requirements, and the St. Ambrose Writing Intensive requirements (2 courses with at least one in the discipline). Students must earn a letter grade of C or better in required written and oral communication and math courses.
- The Health and Wellness outcome will be fulfilled by completing Kinesiology 149 - Wellness Concepts. This course may be completed at St. Ambrose University, transferred as a comparable course, or met through credit by examination.
- The second language requirement will be fulfilled as follows: complete three years of study of the same second language in high school or demonstrate competency through the second semester of a language

at the college level. The language requirement can be met by completing language courses at St. Ambrose University or at the community college if not met with high school course completion.

- The Diversity, Equity and Inclusion Requirement (DEI) will be fulfilled by completing two courses, although transfer students with 60 or more transfer credit hours will be required to complete only one DEI course. Transfer credits do not fulfill this requirement; courses are to be taken at SAU.

#### Student Data and Support

The Parties agree to track the progress and success of this Agreement by cooperatively determining data points that track the admission, retention and degree completion of students pursuing the programs under this Agreement, and report the agreed upon data to each other annually. The Parties will co-advise students in a manner that respects institutional requirements and practices and provides a supportive and unified transfer experience.

#### Marketing

Each Party grants to the other permission to use, display, reproduce, and publish, without compensation, each other's trademarks and other promotional and branding materials for the sole purpose of informing interested parties about this Agreement on websites, cobranded web portals, and in-print marketing publications, with such use conforming to the marketing standards each sets forth. Minimally, the Parties will provide access to this Agreement and Appendices, including any mutually approved modifications, and advising contacts on their respective public websites.

Each Party shall have the opportunity to review in advance any information included on, but not limited to, the aforementioned platforms. Each Party reserves the right to terminate, suspend, or reject the other's use or proposed use of that Party's intellectual property.

#### Implementation Oversight and Communication

The Parties reserve the right to revise or eliminate programs and courses. The Parties will communicate annually concerning curriculum changes that may affect the agreed upon program relationship. #### Accreditation

The Parties will ensure they maintain in good standing their respective accreditation by the Higher Learning Commission and ensure that all operations will be in keeping with the accreditation requirements of their own institution. Any change in accreditation status will be reported by the affected Party to the other Party within thirty (30) calendar day of the change.

#### Term / Modification / Renewal / Termination

This Agreement will be in effect immediately upon final signing, be reviewed annually by the Parties, and will remain in effect for a period of 3 years. This Agreement may be modified by mutual, written agreement of both Parties. This Agreement will automatically renew for 3-year terms unless either party notifies the other in writing by December 31 of the year preceding the last year of the Agreement of their intention for modification or nonrenewal.

Either Party may terminate this Agreement for convenience upon one hundred eighty (180) days prior written notice to the other Party. Further, either Party may terminate this Agreement immediately upon substantial breach by the other Party. In the event of termination, students whose admission to SAU has been accepted under this Agreement will be allowed to transfer to SAU according to the agreement terms in effect immediately prior to

termination, and students will then stay continuously enrolled in BHC and/or SAU and make satisfactory academic progress.

**Entire Agreement**


This Agreement constitutes the entire agreement between the parties, and all prior discussions, agreements and understandings, whether verbal or in writing, are hereby merged into this Agreement.
