



Financial Aid Checklist

for 2025-26 Student Success

- ☐ Create an expandable college folder where you can store all of your printed information, applications and forms for future reference.
- ☐ Obtain your **Federal Student Aid ID (FSA ID) username and password**. New users should create a FSA ID **as soon as possible** at www.studentaid.gov/fsa-id/ by selecting "Create an Account."
- ☐ Complete the **2025-26 FAFSA** at www.studentaid.gov. The application will be available by December 1, 2024. (Students should submit before **June 1, 2025** to avoid delays, late fees and dropped classes.)
- ☐ Are you a new student or returning after a two-year absence? Submit your online application for admission at www.bhc.edu/apply.
 - After receiving your acceptance email, log in to myBHC (mybhc.bhc.edu/) to access your BHC email. This is how the Financial Aid Office will communicate important information!
- ☐ Apply for BHC scholarships in the spring – visit www.bhc.edu/scholarships for deadlines and details!
- ☐ **Actively monitor your myBHC email for status updates. The first 2025-26 financial aid email notifications will be sent in early April 2025.**
 - Did your financial aid email ask you to complete additional requirements? Complete them before **July 1** to avoid delays and dropped classes for the fall semester.
 - Did your financial aid email confirm your eligibility? Don't forget to review the information and resources included in the email notification – it's important, too!
- ☐ **To confirm your financial aid is ready by the payment deadline, review your Charges & Financial Aid for Term on myBHC under My Financial Aid.** Allow 24 hours after registration for updates.
 - Have a balance due? Learn about making payment arrangements at www.bhc.edu/payments.
 - Need a student loan? Learn more and apply before **July 1** at www.bhc.edu/loans.
 - Expecting a financial aid refund? Learn how to select a refund method at www.bhc.edu/refund.
 - Need books and supplies? You can use leftover financial aid at either BHC bookstore each semester www.bhc.edu/bookstore.
 - Review additional details and what to expect at www.bhc.edu/financialaid.
- ☐ **Thinking about adding or dropping classes after the semester has started?** Contact the Financial Aid Office first to understand how your aid may be impacted!

Keep it safe!

Your FSA ID and password act as your legal, electronic signature – you will use it every year to apply. Do NOT share it with others.

Don't wait! New users should create an FSA ID now as it can take 2-3 days to authenticate before use.

When completing the 2025-26 FAFSA, any contributor may need:

- ☐ FSA ID
- ☐ Date of birth
- ☐ Social Security number or Permanent Resident Card
- ☐ 2023 federal tax return
- ☐ 2023 W-2/1099 forms
- ☐ 2023 child support received
- ☐ Current bank statements
- ☐ Current net worth* of investments (excludes retirement)
- ☐ Current net worth* of business or farm (some exclusions apply)

*Net worth means current value of asset minus debt related to that asset.
